

**Ordinance No. 98-3**

AN ORDINANCE AMENDING THE OFFICIAL ZONING MAP, REZONING CERTAIN PROPERTIES ON WEST 7<sup>TH</sup> STREET, GALENA, KANSAS FROM C-1 OR R-1 AS APPROPRIATE TO C-2 GENERAL BUSINESS.

Whereas the Galena Planning Commission held a public hearing on Tuesday, January 13, 1998 at 7:00 p.m. in the City Hall to consider rezoning 9 parcels of land from C-1 or R-1 as appropriate to C-2 General Business; and

Whereas a number of citizens and landowners at the public hearing endorsed the proposed rezoning; and

Whereas the Planning and Zoning Commission voted unanimously after the public hearing on January 13, 1998 to recommend to the City Commission to accept the proposed zoning changes on West 7<sup>th</sup> Street, and


Whereas, the City Commission considered said recommendation and voted unanimously to accept said recommendation;


