

ORDINANCE NUMBER 00-3

AN ORDINANCE ESTABLISHING SPECIFIED COURT COSTS OF THE MUNICIPAL COURT OF THE CITY OF GALENA, KANSAS, PURSUANT TO CHARTER ORDINANCE NUMBER 14 AND BY THE KANSAS STATUTES ANNOTATED AND BY AMENDMENTS THEREOF; RELATING TO THE PAYMENT OF SAID COSTS TO THE SPECIFIED FUNDS AS ESTABLISHED BY THE KANSAS STATUTES ANNOTATED AND BY CITY ORDINANCES, MADE AND PROVIDED FOR HERETOFORE.

SECTION 1. The Municipal Court of the City of Galena, Cherokee, County, Kansas, under and by virtue of Charter Ordinance Number 14, passed by the Governing Body on the 7th, day of February, 2000, and which was duly published on February 23rd, 2000 and March 1st, 2000, and upon which the 61 day protest term expired on May 3rd, 2000, hereby establishes court costs for said Court in the amount of forty-six dollars (\$46.00).

SECTION 2. That the Court costs shall be assessed against the accused person in any City of Galena, Kansas Municipal Court Case where the accused person pleads guilty, no contest or nolo contendere, is found guilty or is offered and enters into a diversion agreement with the Galena City Attorney, as prosecutorial representative of the City of Galena, Kansas. The Municipal Court costs established herein shall not apply to parking violations.

SECTION 3. The Court Costs of the Municipal Court of the City of Galena, Kansas shall be assessed as follows:

- (a) to the General Fund of the City of Galena, Kansas for the administration of justice in the amount of Thirty-two dollars and Fifty-cents (\$32.50);
- (b) to the Local Law Enforcement Training reimbursement fund established pursuant to K.S.A. 74-5620 and amendments thereto, the sum of One dollar (\$1.00);
- (c) to the Law Enforcement training center fund established pursuant to K.S.A. 74-5619, and amendments thereto, the sum of Two dollars (\$2.00);
- (d) to the Juvenile Detention Facilities fund established pursuant to K.S.A. 79-4803, and amendments thereto, to be expended for operational costs of facilities for the detention of juveniles, the sum of Two dollars (\$2.00); to the Protection from Abuse fund established pursuant to K.S.A. 74-7325, and amendments thereto the sum of Fifty cents (\$.50);
- (e) to the Crime Victims Assistance Fund established pursuant to K.S.A. 74-7334 and amendments thereto, the sum of Fifty cents (\$.50);
- (f) to the Trauma Fund established pursuant to Chapter 127, of the 1999 Session Laws of Kansas, Section 8 and Section 9 (3) the sum of One dollar (\$1.00);
- (g) to the Training, testing and continuing judicial education of municipal judges as provided in K.S.A. 12-4114 and K.S.A. 12-4116 and K.S.A. 20-1a11 and amendments thereto, the sum of Fifty-cents (\$.50);
- (h) to the Galena City Attorney equipment, training and continuing legal education fund which is hereby established to defer the costs of continuing legal education and equipment deemed necessary by the City Manager for the City Attorney's office which shall be administered by the City Clerk of the City of Galena, Kansas and shall be disbursed at the discretion of the City Manager, the sum of One dollar (\$1.00);

- (i) to the City of Galena Local Law Enforcement Training Fund, as established by City Ordinance Number 94-8, the sum of Five dollars (\$5.00).

SECTION 4. SEVERABILITY. If any provision of this Ordinance is declared unconstitutional, or the application thereof to any person or circumstance is held invalid, the constitutionality of the remainder of the code and the applicability thereof to other persons and circumstances shall not be affected thereby.

SECTION 5. REPEAL. Any ordinance in conflict herewith is hereby repealed.


