AN ORDINANCE VACATING ALLEY LAYING BETWEEN LOT 79 AND LOTS 58 THROUGH 63 OF THE EMPIRE TOWN COMPANY'S FIFTH ADDITION TO THE CITY OF GALENA, CHEROKEE COUNTY, KANSAS PURSUANT TO K.S.A. 14-423.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF GALENA, KANSAS THAT THE REAL ESTATE DESCRIBED AS FOLLOWS IS HEREBY VACATED:

Beginning at the SE corner of Lot 79, of the Empire Town Company's Fifth Addition to the City of Galena, Cherokee County, Kansas; then North 150 feet to the NE corner of said Lot 79; then East 20 feet to the NW corner Lot 58, of the Empire Town Company's Fifth Addition to the City of Galena, Cherokee County, Kansas; then South 150 feet to the SW corner of Lot 63, of the Empire Town Company's Fifth Addition to the City of Galena, Cherokee County, Kansas; then West 20 feet to the point of beginning.


This Ordinance reserves to the City of Galena, Kansas and public utilities in the vacated land such rights-of-way and easements as are necessary and desirable for public utility service.

This Ordinance shall take effect and be in full force thirty (30) days after the date of publication in the *Galena Sentinel-Times*.
