ORDINANCE NO. 06-04

Be it ordained by the Governing Body of the City of Galena, Kansas.

SECTION 1. The following described real estate located in the City of Galena, Kansas, located on the Northwest corner of the location where Old 7th Street and Stateline Road intersect, containing approximately 3.7 acres, is hereby rezoned from a R-1 District to a M-2 District, said property being legally decribed as follows with the below-stated legal description to control over any inconsistency with any previously-stated informal description herein:

Commencing at a point 660 feet East of the Southwest Corner of Lot 4 in Section 13, Township 34, Range 25, thence North 660 feet, thence East to the Missouri and Kansas state line, thence South along the state line 660 feet, thence West to the point of beginning except the North 200 feet in Cherokee County, Kansas.

SECTION 2. The Official Zoning Map of the City of Galena shall be amended to reflect the changes in zoning classification approved herein.

SECTION 3. This Ordinance shall take effect and be in full force upon its publication once in the official city newspaper.
