

ORDINANCE NUMBER 06-06

AN ORDINANCE ESTABLISHING SPECIFIED COURT COSTS OF THE MUNICIPAL COURT OF THE CITY OF GALENA, KANSAS, AND DIRECTING THE PAYMENT OF SAID COSTS TO THE SPECIFIED FUNDS AS ESTABLISHED BY THE KANSAS STATUTES ANNOTATED AND BY CITY ORDINANCES.

SECTION 1. That the Court costs shall be assessed against the accused person in any City of Galena, Kansas Municipal Court case where the accused person pleads guilty, no contest or nolo contendere, is found guilty, or is offered and enters into a diversion agreement with the Galena City Attorney, as prosecutorial representative of the City of Galena, Kansas in the amount of Seventy Dollars \$70.00 for a traffic infraction or traffic misdemeanor case, and One Hundred Twenty-seven Dollars \$127.00 for a misdemeanor case not traffic related. The Municipal Court costs established herein shall not apply to parking violations.

SECTION 2. The Court Costs of the Municipal Court of the City of Galena, Kansas shall be assessed as follows:

- (a) to the General Fund of the City of Galena, Kansas for the administration of justice in the amount of Thirty-nine Dollars (\$39.00) for a traffic infraction or a traffic misdemeanor, and Ninety-six Dollars (\$96.00) for a misdemeanor case not related to traffic;
- (b) to the Local Law Enforcement Training reimbursement fund established pursuant to K.S.A. 74-5620 and amendments thereto, the sum of One Dollar (\$1.00);
- (c) to the Law Enforcement training center fund established pursuant to K.S.A. 74-5619 and K.S.A. 12-4117, and amendments thereto, the sum of Nineteen Dollars and fifty cents (\$19.50);
- (d) to the Juvenile Detention Facilities fund established pursuant to K.S.A. 79-4803, and amendments thereto, to be expended for operational costs of facilities for the detention of juveniles, the sum of Two Dollars (\$2.00); to the Protection from Abuse fund established pursuant to K.S.A. 74-7325, and amendments thereto the sum of Fifty cents (\$.50);
- (e) to the Crime Victims Assistance Fund established pursuant to K.S.A. 74-7334 and amendments thereto, the sum of Fifty cents (\$.50);
- (f) to the Trauma Fund established pursuant to Chapter 127, of the 1999 Session Laws of Kansas, Section 8 and Section 9 (3) the sum of One Dollar (\$1.00);
- (g) to the Training, testing and continuing judicial education of municipal judges as provided in K.S.A. 12-4114 and K.S.A. 12-4116 and K.S.A. 20-1a11 and amendments thereto, the sum of Fifty cents (\$.50);
- (h) to the Galena City Attorney equipment, training and continuing legal education fund which is hereby established to defer the costs of continuing legal education and equipment for the City Attorney's office which shall be administered by the City Clerk of the City of Galena, Kansas the sum of One Dollar (\$1.00);
- (i) to the City of Galena Local Law Enforcement Training Fund, as established by City Ordinance Number 94-8, the sum of Five Dollars (\$5.00).

SECTION 3. SEVERABILITY. If any provision of this Ordinance is declared unconstitutional, or the application thereof to any person or circumstance is held invalid, the constitutionality of the remainder of the code and the applicability thereof to other persons and circumstances shall not be affected thereby.

SECTION 4. REPEAL. Any ordinance in conflict herewith is hereby repealed.

ORDINANCE NUMBER 06-06

SECTION 1. That the Court costs shall be assessed against the accused person in any City of Galena, Kansas Municipal Court case where the accused person pleads guilty, no contest or nolo contendere, is found guilty, or is offered and enters into a diversion agreement with the Galena City Attorney, as prosecutorial representative of the City of Galena, Kansas in the amount of Seventy Dollars \$70.00 for a traffic infraction or traffic misdemeanor case, and One Hundred Twenty-seven Dollars \$127.00 for a misdemeanor case not traffic related. The Municipal Court costs established herein shall not apply to parking violations.

SECTION 2. The Court Costs of the Municipal Court of the City of Galena, Kansas shall be assessed as follows:

- (a) to the General Fund of the City of Galena, Kansas for the administration of justice in the amount of Thirty-nine Dollars (\$39.00) for a traffic infraction or a traffic misdemeanor, and Ninety-six Dollars (\$96.00) for a misdemeanor case not related to traffic;
- (b) to the Local Law Enforcement Training reimbursement fund established pursuant to K.S.A. 74-5620 and amendments thereto, the sum of One Dollar (\$1.00);
- (c) to the Law Enforcement training center fund established pursuant to K.S.A. 74-5619 and K.S.A. 12-4117, and amendments thereto, the sum of Nineteen Dollars and fifty cents (\$19.50);
- (d) to the Juvenile Detention Facilities fund established pursuant to K.S.A. 79-4803, and amendments thereto, to be expended for operational costs of facilities for the detention of juveniles, the sum of Two Dollars (\$2.00); to the Protection from Abuse fund established pursuant to K.S.A. 74-7325, and amendments thereto the sum of Fifty cents (\$.50);
- (e) to the Crime Victims Assistance Fund established pursuant to K.S.A. 74-7334 and amendments thereto, the sum of Fifty cents (\$.50);
- (f) to the Trauma Fund established pursuant to Chapter 127, of the 1999 Session Laws of Kansas, Section 8 and Section 9 (3) the sum of One Dollar (\$1.00);
- (g) to the Training, testing and continuing judicial education of municipal judges as provided in K.S.A. 12-4114 and K.S.A. 12-4116 and K.S.A. 20-1a11 and amendments thereto, the sum of Fifty cents (\$.50);
- (h) to the Galena City Attorney equipment, training and continuing legal education fund which is hereby established to defer the costs of continuing legal education and equipment for the City Attorney's office which shall be administered by the City Clerk of the City of Galena, Kansas the sum of One Dollar (\$1.00);
- (i) to the City of Galena Local Law Enforcement Training Fund, as established by City Ordinance Number 94-8, the sum of Five Dollars (\$5.00).

SECTION 3. SEVERABILITY. If any provision of this Ordinance is declared unconstitutional, or the application thereof to any person or circumstance is held invalid, the constitutionality of the remainder of the code and the applicability thereof to other persons and circumstances shall not be affected thereby.

SECTION 4. REPEAL. Any ordinance in conflict herewith is hereby repealed.
