

ORDINANCE NO. 06-17

AN ORDINANCE VACATING CERTAIN PORTIONS OF SCOTT STREET, GIRARD STREET, ELM STREET, AND CERTAIN ALLEYS AS DESCRIBED BELOW.

BE IT ORDAINED BY THE GOVERNING BODY OF GALENA, KANSAS, THAT:

Section 1. The platted streets and alleys legally described below are hereby vacated, to-wit:

Scott Street: Beginning at the NW corner of Lot 161 of the Fifth Addition to Empire City, Galena, Kansas, then West 60 ft. to the NE corner of Lot 182 of said Fifth Addition, then South to the SE corner of Lot 178 of said Fifth Addition, then East 60 ft. to the SW corner of Lot 177 of said Fifth Addition, then North to the point of beginning.

Girard Street: Beginning at the NW corner of Lot 137 of the Fifth Addition to the Empire City, Galena, Kansas, then West 60 ft. to the NE corner of Lot 138 of said Fifth Addition, then South to the SE corner of Lot 154 of said Fifth Addition, then East 60 ft. to the SW corner of Lot 121 of said Fifth Addition, then North to the point of beginning.

Elm Street: Beginning at the SE corner of Lot 126 of the Fifth Addition to Empire City, Galena, Kansas, then West to the SW corner of Lot 180 of said Fifth Addition, then South 60 ft. to the NW corner of Lot 179 of said Fifth Addition, then East to the NE corner of Lot 125 of said Fifth Addition, then North 60 ft. to the point of beginning.

Alley: Beginning at the NW corner of Lot 160 of the Fifth Addition to Empire City, Galena, Kansas, then West 20 ft. to the NE corner of Lot 161 of said Fifth Addition, then South to the SE corner of Lot 177 of said Fifth Addition, then East 20 ft. to the SW corner of Lot 156 of said Fifth Addition, then North to the point of beginning.

Alley: Beginning at the NW corner of Lot 138 of the said Fifth Addition to Empire City, Galena, Kansas, then West 20 ft. to the NE corner of Lot 159 of said Fifth Addition, then South to the SE corner of Lot 155 of said Fifth Addition, then East 20 ft. to the SW corner of Lot 154 of said Fifth Addition, then North to the point of beginning.

Alley: Beginning at the SE corner of Lot 132 of the Fifth Addition to Empire City, Galena, Kansas, then West to the SW corner of Lot 183 of said Fifth Addition, then South 20 ft. to the NW corner of Lot 180 of said Fifth Addition, then East to the NE corner of Lot 131 of said Fifth Addition, then North 20 ft. to the point of beginning.


