AN ORDINANCE ESTABLISHING FULL-TIME POSITIONS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF GALENA, KANSAS that:

Section 1. FULL-TIME POSITIONS ESTABLISHED. The following full-time employment position is established for the City of Galena: Code Enforcement / Animal Control Officer. The Code Enforcement / Cemetery Sexton position is hereby abolished. The Code Enforcement / Animal Control Officer shall be paid at a rate of \$9.56 per hour. The following full-time employment position is established for the City of Galena: Court Clerk / Office Associate. The part-time Court Clerk / Office Associate position previously created under Ordinance 07-03 is hereby abolished. The Court Clerk / Office Associate shall be paid \$10.00 per hour.

Section 2. EFFECTIVE DATE. REPEAL. This ordinance shall take effect upon publication in the official city newspaper. Any provisions contained in any prior ordinances in conflict herewith are repealed.

AN ORDINANCE ESTABLISHING FULL-TIME POSITIONS.


BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF GALENA, KANSAS that:


