

ORDINANCE NO. 08-11

AN ORDINANCE ESTABLISHING PAY FOR EMPLOYEES

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF GALENA, KANSAS that:

Section 1: PAY ESTABLISHED. The following pay is established for each respective employee on a particular line herein.

Section 2: The positions of Chief of Police, Superintendent of Public Works, City Clerk, City Treasurer, City Surveyor, Municipal Court Judge and City Attorney are exempt positions, which means they do not receive overtime pay or compensatory time.

Section 3: Nothing in this enactment shall prevent the City Council from adding, changing, or combining positions and job classifications.

Section 4: EFFECTIVE DATE: This ordinance shall be in full force and effect upon publication in the official city newspaper. Provided, the pay scale provided for in this ordinance shall not commence until December 28, 2008.
