ORDINANCE NO. 11-08

AN ORDINANCE ESTABLISHING PAY FOR EMPLOYEES

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF GALENA, KANSAS that:

Section 1: PAY ESTABLISHED. The following pay is established for each respective employee on a particular line herein.

Section 2: Nothing in this enactment shall prevent the City Council from adding, changing, or combining positions and job classifications.


