ORDINANCE NO. 16-1

AN ORDINANCE ESTABLISHING PAY FOR EMPLOYEES

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF GALENA, KANSAS that:

Section 1. PAY ESTABLISHED. The following pay is established for each respective employee on a particular line herein:


Section 2. Nothing in this enactment shall prevent the City Council from adding, changing, or combining positions and job classifications.

Section 3. EFFECTIVE DATE: This ordinance shall be in full force and effect upon publication in the official city newspaper. Provided, the pay scale provided for in this ordinance shall not commence until January 1, 2016.

Section 4. REPEAL: This ordinance shall take effect upon one publication in the official city newspaper. Any provisions contained in any prior ordinances in conflict herewith are hereby repealed. Ordinance 14-1 is hereby repealed.
