

ORDINANCE No. 21 - 04

AN ORDINANCE ESTABLISHING GUIDELINES FOR GRAVE SITES AND OPENINGS, PRICES AND FEES, AND CONDUCT OF FUNERALS IN THE OAK HILL, HILLCREST, AND GALENA CEMETERIES OF THE CITY OF GALENA, KANSAS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF GALENA, KANSAS, THAT:

Section 1: GRAVE SITES AND OPENINGS; PRICES AND FEES.

- (a) The price of a grave site (burial plot) at the Oak Hill, Hillcrest, or Galena Cemeteries is hereby set at \$200 per site.
- (b) A fee of \$300.00 to open a grave at the Oak Hill, Hillcrest, or Galena Cemeteries shall be charged Monday through Friday.
- (c) A fee of \$150.00 to open a cremation space at the Oak Hill, Hillcrest, or Galena Cemeteries shall be charged Monday through Friday.
- (d) A fee of \$375.00 to open a grave site (burial plot) at the Oak Hill, Hillcrest, or Galena Cemeteries shall be charged Saturday.
- (e) A fee of \$225.00 to open a cremation space at the Oak Hill, Hillcrest, or Galena Cemeteries shall be charged Saturday.
- (f) A fee of \$125.00 shall be charged for grave openings under five feet, other than cremation spaces, or for emergency county burials.
- (g) Infant grave openings shall be free.
- (f) There shall be no Sunday or holiday openings unless an emergency County burial.

Section 2:


OAK HILL CEMETERY, HILLCREST CEMETERY, AND GALENA CEMETERY; CONDUCT OF FUNERALS. The oak Hill, Hillcrest, and Galena Cemeteries shall be open for the conduct of funerals during normal working hours, subject to the following provisions and regulations:

- (a) The cemetery sexton shall not normally be required to be on duty between the hours of 4:30 PM Friday and 8:00 AM Monday of any week of any year.
- (b) No funeral services are to be conducted on any officially recognized holiday normally observed by the City of Galena, on any Sunday, nor after 2:00 PM on any Saturday (except emergency County burials).
- (c) In the event that any funeral home shall desire to conduct a funeral at any of the cemeteries on a Saturday, the fees stipulated in Section 1 above shall prevail and they shall be the liability of the funeral home conducting the funeral.

Section 3: Any Ordinances of the City of Galena in conflict herewith are hereby amended.

Section 4: This Ordinance shall take effect and be in full force from and after the date of its passage and publication once in the official city newspaper, The Galena Sentinel-Times.
