RE: Evening Ambient Air Monitoring Activity – 8/21/2026

Dear Mr. Reed,

Ambient air monitoring was conducted on the evening of August 21, 2026, for hydrogen sulfide (H₂S) around the Jordan Disposal Landfill. Per manufacturer recommendations, the Jerome J605 unit was regenerated and fresh air “zeroed” using the appropriate zero air filter prior to sampling the ambient air for H₂S concentrations at eight (8) predetermined locations. Basic weather information was collected at each location at the time of sampling from the Apple Weather Application and documented along with the H₂S reading from the J605 unit. The sampling locations are exhibited in Figure 1 attached to this summary letter, and the collected data is presented in Table 1 below.
